Council debt shoots to ZWL\$14 billion

arare City council is now owed ZWL\$14 billion by residents, business and Government.

The huge growing debt is affecting service delivery. The debt has almost doubled from the ZWL\$8 billion in July this year.

The city is struggling to provide service delivery due to non-payment for services by stakeholders and this has also negatively affected development plans.

Domestic users remain the highest debtors owing the local authority ZWL\$5 billion dollars while commerce owes the city just under ZWL\$4 billion and industry is on ZWL\$2 billion dollars.

Government owes the city ZWL\$500 million.

The city's Corporate Communications manager Michael Chideme encouraged stakeholders to pay their dues so that the local authority can up the game in service delivery.

"We have always said that we cannot do anything when stakeholders do not pay. The money that we use for service delivery comes from them."

"We are asking ratepayers to honour their obligations to Council so that the city can provide superior services they always ask for.

"Ratepayers fund service delivery and without their support, everything suffers," he said.

ouncil is procuring more refuse trucks and associated equipment to augment its current fleet.

Acting Amenities Head, Eng Keith Mapunzamoyo said the existing fleet is being repaired. "We are now at the various stages of procurement. Some tenders have already been awarded for example, refuse compactors where we are at contract negotiation stage with the two suppliers," he said.

"We are at tender evaluation stage for some of the equipment. We should receive some equipment before the year end.

"On the medium to long term, Council is looking on introducing integrated waste management practices urging residents to separate waste at source," he said.

He said his division is embarking on awareness campaigns to educate residents on how to minimize dumping as well as proper waste management systems that reduce the amount of garbage carried by council.

Eng Mapunzamoyo said Council will establish material recovery centres at various centres in the city.

EMA declares ecological sensitive areas

The Minister of Environment, Climate, Tourism and Hospitality industry has, in terms of section 113(1) of the Environmental Act (Chapter 20.27) issued a public notice of intention to declare Ecologically Sensitive Areas in the capital.

The declaration by the Minister means that there shall be limitations on developments in and around such areas.

Areas identified in Harare include wetlands in Borrowdale Brooke, Bluffhill, Chisipite, Cleverland Dam, Helensvale, Hatfield, Houghton Park, Glen Lorne, Northwood, Prospect, Budiriro, Rockview, Tynwald, Greystone Park, Malborough, Mt Pleasant, Sunway City, Vainona, Waterfalls, Westlea, Warren Park, Mufakose, Mukuvisi, Monavale, Manyame, National Sports Stadium, Ashbrittle, Braeside, Belvedere, Carrick Creach, Caledonia, Dzivarasekwa, Epworth, Eastlea, Highlands, Glenview, Seke Dam, The Grange, University of Zimbabwe, Midlands, Harare South, Dzivarasekwa, Green Groove, Kutsaga, Mbare, Mabvuku, Tafara, Rugare and Willovale, Milton Park, Rockview.

According to a recent statement by the Environmental Management Agency,

any person who has submissions to make on the intended declaration should contact the agency.

City improves water testing laboratories

The City of Harare is remodelling its water testing laboratories to meet ISO 17025 standards.

Council has so far been able to improve the laboratory at Cleveland Building with the assistance of Vei, a Dutch company that has interests in water, and is now working on the one at Morton Jaffray's Waterworks.

City Acting Chief Chemist Mr Mugove Chabuda confirmed the development saying this will help improve stakeholder confidence in the council water.

"The Morton Jaffray onsite laboratory which is responsible for water quality testing one every two hourly basis is currently under renovation so that it comply with ISO 17025 requirements for water quality testing," he said.

Chabuda said the one at Morton Jaffray is being done using devolution funds availed by Government.

"We are using the devolution funds to improve on our water quality testing and we are also going to equip the lab with the state of the art equipment," he said.

"After the lab is completed we expect it to meet ISO 17025 requirements which will improve our water quality testing and upgrade our research and development of new treatment technologies in City of Harare," he said

Chitembwe said coaches are expected to compete on the pitch and the referees are not supposed to take part but are there to superintend over the laws of the gate.

"We anticipated that, we knew that we are going to play Dynamos as the last game but it's very disappointing to lose a match but like this."

arare City Volleyball Club is expected to launch their bid to retain the national league title this coming weekend after the sport was given the green light to resume by the Sports and Recreation Commission.

The reigning national champions have been on an almost two-year hiatus following successive coronavirus induced lockdowns that brought all sporting activities to a halt and are now preparing to represent the nation at the Zone Six Club Championships that are slated for Mozambique from the 6th to the 16th of January 2022.

The last time Boys and Girls dzeTonaz represented the country at the club championship was in Malawi in 2018 where they finished second and fourth respectively and are aiming to go a step further if the Mozambique trip is successful.

The club has been having a series of friendly matches with the latest matches played at University of Zimbabwe at the weekend where the boys triumphed over old enemies UZ, Support Unit and Chitungwiza Pythons by 2-0 margins.

"We have not played for a long time but I think we will do well because we have been preparing, currently the team is not that good but we think that once the games kick off everything is going to be in good shape and we will do well," he said.

The experienced coach said he is happy with the players at his disposal.

"We are happy with all the players that we have, it would have been better if we have everyone in camp but due to some logistics some players have not yet come down for example we have one player who is in Bulawayo but once everything is sorted out he will come down to join us.

PUBLIC NOTICE

In terms of the Harare Dog Licensing and Control By-Laws, no person shall keep any dog on a premise for any portion of a year commencing on the 1st day of January unless he or she has applied for and obtained a permit or licence.

The dog license fees are as follows:

Dog Male \$1250Spayed female \$940Unspayed female \$1000

The law criminalises keeping more than four dogs or allow more than four dogs over the age of 6 months to be kept in or at premises containing one or two dwelling units.

NB: Our law enforcement teams will be checking for compliance with immediate effect. All stray dogs to be impounded and where necessary will be put to rest.
