Note – With effect from 1.7.1971, the town councils of Greendale, Hatfield, Highlands, Mabelreign, Marlborough, Meyrick Park, Mount Pleasant and Waterfalls were abolished and their respective areas incorporated in the area of the Municipality of Harare. By RGN 261 of 1971, certain by-laws existing in these areas continued in force as though they were made by the council.
